- 1.1 The President welcomed everyone for taking time off to be present at this tenth Annual General Meeting (AGM) of the Green Productivity Association Malaysia. She thanked all members for taking time off to attend this morning's Meeting.
- 1.2 The meeting was informed that Association was established in 2001. During the last decade, the Association had strived to contribute to higher productivity but due to our limited resources, the Association had only achieved a certain level of success. We had 'cleaned' up our membership list to that those whom we are not able to contact had been removed from the membership register The President further said that the Association had conducted a few training programs under the Service Sector Capacity Development Fund (SSCDF) of the Malaysian Industrial Development Authority (MIDA), Ministry of International Trade & Industry (MITI) via a in the service sector.  - c. Seminar on SEA using RIAM in Strategic Planning from 8-9 June 2010 at Evergreen Laurel Hotel, Penang

IGEM2010

TheInternational Greentech & Eco Products Exhibition and Conference Malaysia' (IGEM2010) was held from 14-17 October 2010 at the Kuala Lumpur Convention Centre (KLCC). GPAM was a supporting organization for this event; which turned out to be a great success with 277 exhibitors from 24 countries and region. It was attended by 86,372 visitors from 59 countries.

The meeting was informed that for the current year, the Association will again support IGEM2011 in line with the government effort in promoting green growth as well as Malaysia as the green technology hub for the region. IGEM2011 will be held from 7-10

September 2011 at KLCC. Members are encouraged to visit the exhibition as well as participate in the concurrently held conference and workshops.

Community-based Composting & Material Recycling Training

3.5 A proposal was received to conduct the above training with Zainab Enterprise Sdn Bhd, Klang. in February 2011. The Exco members comprising the President, Secretary General, Deputy Secretary General and Puan Kamariah held a discussion with the Managing Director of the company. However, the company did not revert the Association's proposal to have the training conducted regularly.
