## ANNUAL GENERAL MEETING MINUTES OF MEETING

#### 1. President's Address

- 1.1 The President welcomed everyone for taking time off to be present at this Annual General Meeting (AGM) of the Green Productivity Association Malaysia. The President noted that even though the Association had successfully recruited two new members in 2015 and one new member so far in 2016 but due to the lack of membership drive activities, this effort has not been encouraging.

- 2. Confirmation of Minutes of AGM
- 2.1 Minutes of the last Annual General Meeting of the Association which was held on 20 June 2015 was approved by all members present with no amendments.
- 3. Annual Report by the Secretary General

#### 3.1 Membership

#### 4. Financial Report

Both the Financial Report and Internal Auditors' Report was unanimously approved and accepted by the Meeting.
- The meeting also agreed that members whose membership fees has been outstanding for more than 4 years be removed from the membership list. Letters will sent to these members.
- The meeting noted that the monthly statement of the Association's only bank account at the RHB Bank, PJ Branch (Account Number 21219800011624) will be sent to the treasurer's address with effect from July 2016 to facilitate the reconciliation of the account.

#### 5. Other matters

- 5.1 Members are encouraged to propose projects or activities for the Association.
- 5.2 Any member can request for GPAM name cards. They should forward their request to the Secretary.
- 5.3 GPAM will be collaborating with University of Malaya Centre for Continuing Education (UMCCed) on a one day training program on Solid Waste Management.
- Pn. Kamariah will be working closely with the local authority on the Selangor Conference on Solid Waste Management as well as CSR with firms in the Shah Alam locality.
- 5.5 Dr. Sarala volunteered to assist in the GPAM website content.
